1 Project Selection and Start


The client chooses between Base / Premium / Golden. WEBCLICKA provides the list of available BootstrapMade templates (current number and updates indicated in the brochure).

Step 1.2 Content Collection (Clarification)

WEBCLICKA provides the main texts and revises them using artificial intelligence for basic SEO optimization. It may request specific images from the client; if images are not received within 15 days of the brief, WEBCLICKA will use default template images.

Step 1.3 Contract and Initial Payment (50%)

The contract includes: I final revision cycle; file ownership managed by WEBCLICKA (see clause and export option); paid export backup option; annual renewal conditions; reference to attached extra services price list.





2 Development – Website Creation

Step 2.1 Shared VPS Setup Included Specifications: 1-core CPU, 4 GB RAM, 50 GB storage. Hosting included. Basic uptime monitoring included. Minimal automatic backup included (retention 7 days for Base package; 30 days for Premium/Golden).

Step 2.3 Basic SEO

Included: meta tags, alt attributes, robots.txt, sitemap.xml. Texts optimized with Al for basic on-page SEO improvement.


Review and Delivery Phase

Step 3.1 – Single Review

The client receives a preview for final verification. Correction of technical errors is included in the cycle. Contractual distinction: 'technical error' = bug, malfunction; 'aesthetic change' = layout/structure variations (extra).

Step 3.2 – Delivery and Balance Payment (50%)

Publication on the client's domain. Source files not released. Export Backup option (paid service): €80 for static sites / €150 for CMS (files + database). Export provided as a zip; no support for restoration on third-party infrastructures.


